U.S.A. In A Nutshell updated September 5, 2015 - by michael-herbert: keehn

The <u>UNITED STATES</u> is not the republic of these united States of America guaranteed by the Constitution:

"The United States shall guarantee to every State in this Union a republican form of government, and shall protect each of them against invasion; and on application of the legislature, or of the executive (when the legislature cannot be convened) against domestic violence." – organic Constitution for the United States; Article IV; Section 4

It is critically important to comprehend that *Republican form of Government* has NOTHING to do with the *Republican Political Party* no more than it has anything to do with the *Democratic Political Party*. To better comprehend what is meant by <u>*Republican form of Government*</u>, one might read the document found at the blue link.

When we analyze any part of the constitution, we must take into account whether or NOT the corporate United States was yet in existence. The corporate United States came into existence in 1871. Since the above *Constitutional extract* was taken from the *organic* (original, before being altered - 1789) Constitution, "The United States¹" corporate did not yet exist. Once "The United States" corporate came into existence, it muddied the waters of distinction between the republic of these united States of America, and "The United States" corporate. They are two distinct entities, but Leadership, by and through their control of public-school-curriculum, has gone out of their way to make certain that public school students are not taught the difference. Thus, we have a tendency to be *caught off balance* the first time we are introduced to this fact. In this document the republic of the United States will be identified as the *republic of these united States of America*, whereas "The United States" corporate will be identified as shown in the quotes.

An organic law is a law of we the people, as in:

"WE THE PEOPLE of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defense, promote the general Welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America." – Constitution for the United States; Preamble

Quite possibly, most people do not know this. And although there are many fine documents available at <u>http://mhkeehn.tripod.com/</u> as well as other locations on the web, most of them are a bit lengthy and can be a chore for some. This construct is an effort to reduce the confusing situation of government into a nutshell. There will be little frill here to explain matters in detail, but the meat of the subject is here. For more detail, perhaps it will be necessary to read "<u>My</u> <u>Dear Archbishop Annotated</u>," or without annotations, "<u>My Dear Archbishop</u>," "<u>Do We Have a Clue</u>," "<u>The Core Problem</u>," and/or "<u>Citizenship Examined</u>" at the above website. O-K, here we go...

These united States of America were in <u>debt</u> at the conclusion of the Revolutionary War and this has been the struggle all along the way. Initially, ENGLAND [actually the *English Bankers*, by and through the English Government] became our <u>creditor</u> and paid off all the other creditors who had financed the *Revolutionary War* for the colonists (Americans). The collateral for the loan was all the property held by the Federal Government. As part of the deal, a bank (80% English owned and 20% American owned, soon to become 100% English owned) was chartered, in 1791, by Congress for 20-years to engage in Banking, but also to hold the collateral (titles to the property) that secured the loan.

In 1811, the bank's Charter expired and Congress refused to renew the Charter. This, in turn, required the bank to close its doors. However, the loan had not yet been paid to England (the *English Bankers*) by the leadership of these united States of America. This angered the *English Bankers* and using their influence over the English Government, mobilized England's military, resulting in the war of 1812 with England. The English attacked Washington, District of Columbia, burned the White House, burned the personal home of President James Madison, entered the Federal Courts where the titles to the collateral property had been placed, and recovered their collateral. The upshot of this war was that Congress renewed the bank's Charter, and the happy English went back home.

Andrew Jackson paid off the debt during his Presidency and these united States of America was out of debt for a brief period of time. But then came the Civil War and with it, DEBT, again owed to England! This new debt was due and payable in 1871 and the leadership of these united States of America defaulted on payment. Thus, the *creditor*, England, acting on behalf of the English Bankers, took possession of the collateral property which included Washington, District of Columbia. Through banking stealth, England was conquering these united States of America, and no, neither the *free and independent press* (otherwise known as the *mainstream media*) nor Leadership ever notified the American people.

England, as the <u>creditor</u> and new owner of Washington, D.C., was now in control of the Capital and every other resource of the Federal Government by and through DEBT, forced incorporation on the Federal Government. Thus, in 1871 was born the corporation known as "THE UNITED STATES." Yes, the article "THE" is part of the name. If the name was intended to trick the people of these united States of America, we would have to conclude that this deception has done a fairly good job since that time. But more recently we *the people* are beginning to figure it out.

We are learning not to confuse the *commercial corporation* known as "THE UNITED STATES" with the republic of these united States of America.

By virtue of the *security agreement* 2 that we know as <u>the Constitution</u>, the DEBT defaulted to the <u>Union States</u> to pay. The DEBT was due and payable in 1909, and leadership again failed to pay, asking for an extension of time.

Twenty-years of additional time was granted, but with stipulations. One stipulation was the creation of a Central Bank. In 1913, that stipulation was met with the legislation for the creation of the *privately owned* <u>Federal Reserve Bank</u>. And make no mistake about it, the <u>Federal</u> <u>Reserve Bank</u> is owned by the <u>creditor</u>, a collection of elite international Bankers. And this is who your *war for freedom* is with!

In 1929 the DEBT was due and payable, and once again, the elected Leadership defaulted on the payment, placing us in <u>dishonor</u>. But, in our defense, neither our Leadership, our Churches, our Schools, nor our *mainstream misleadia* informed us of the pending obligation and the dire consequences attached. Now, all the property of the <u>Union States</u> became the property of the <u>creditor</u>, evident in the following quote.

"Under the new law the money [*Federal Reserve Notes*] is issued to the banks in return for Government obligations, bills of exchange, drafts, notes, trade acceptances, and banker's acceptances. The money will be worth 100 cents on the dollar, because it is backed by the credit of the Nation. It will represent a mortgage on all the homes and other property of all the people in the Nation." - Congressional record, March 9, 1933, House, Congressman Patman, 73rd Congress, Special Session, Volume 77, part 1, page 83

There you have it. All the property, including your property, whatever you think it might be, has been mortgaged to the <u>creditor</u> for <u>ink on paper</u> (Federal Reserve Notes). Everything you think you own, you don't. You may hold <u>equitable title</u> but not <u>legal title</u>. Thus, you have become an *economic slave*.

So, it's 1929 and we've defaulted on payment of the DEBT again. Enter the depression, engineered by the central bank we know as *the Federal Reserve*. Things limp along until 1933, and five-days into the Franklin D. Roosevelt administration, the Banking Relief Act of March 9, 1933 is passed, the same act being debated in the indented quote above. Roosevelt also issues *executive proclamations* which declare the United States bankruptcy.

In short, the Banking Relief Act contained the language of the <u>Trading with the Enemy Act</u> of October 6, 1917 as recommended by the Federal Reserve Board of New York to former President Herbert Hoover who declined to use it. In examining the *Trading with the Enemy Act* we find

that the United States was dealing with World War I in 1917, and it was recognized that there were enemies of this country doing business within our borders. The <u>Trading with the Enemy Act</u> gave government total authoritarian control over the commercial activities of an *identified enemy*. Remember this term, "*identified enemy*," because it's going to come back to haunt us.

But that original act of 1917 contained some important <u>exclusionary language</u>. One piece of <u>exclusionary language</u> reads, "credits in any form, EXCEPT credits for transactions to be executed wholly within the United States." This was recognition that when you go to the hardware store and buy a lawnmower, which is a transaction executed wholly within the United States, this is NOT an enemy transaction, and not subject to the operation of the law.

It also said at section (c), *except citizens of the United States*. Recognizing that a *citizen of the United States* is NOT an enemy of the United States, and not subject to the operation of the law! Now, here is where the <u>dishonor of Leadership</u> begins to work against us in a big way.

As already stated, the Banking Relief Act contains the language of the Trading with the Enemy Act, but the *exclusionary language* in the paragraph above is amended in the Banking Relief Act and becomes, *by any person living within the United States or subject to the jurisdiction thereof.*

This means that the *domestic transactions* (transactions executed wholly within the United States) are no longer exempted from the operation of the law. It also means that *citizens of the United States* are no longer exempted from the operation of the Trading with the Enemy Act language.

It should now be clear that if we are not exempted from the language of an ACT OF WAR (the Trading with the Enemy Act) then <u>WE</u> have become an <u>IDENTIFIED ENEMY OF THE</u> <u>UNITED STATES</u>. And we have openly and notoriously seen this change in our status. Remembering that the <u>Trading with the Enemy Act of October 6, 1917</u> gave government total authoritarian control over the <u>commercial activities</u> of an identified enemy, we need only examine our own activities since 1933. If we examine our activities before and after 1933, we will find that all of our normal and regular activities have been <u>converted</u> into a <u>commercial activity</u>.

Our marriage is commercial, giving birth to children is commercial, their education is commercial, laboring to feed our family is commercial, our travel is commercial, our access to ground water is commercial, providing shelter for our self and family is commercial, our collection of rain water is commercial, our growing of vegetables is commercial, our bake sales are commercial, the lemonade stand of our children is commercial, all aimed at total control of our lives, **and ringing the Government's bankrupt cash register**.

And ringing the <u>Governments bankrupt cash register</u> to continue operation (for a while) in bankruptcy <u>is what governmental systems have been about since 1933</u>. The courts are administering the bankruptcy of the United States by tapping the one asset that remains, you and your productivity.

"Judges are instructed to take "silent judicial notice" that America is a bankrupt nation. As such, it is not operating under Constitutional Law but under certain 'public bankruptcy policies,' the very existence of which is not to be made general public knowledge." – <u>Sui Juiris, Pardon me but...</u> #5, page 11

The passage of the Banking Relief Act, which we should remember contains the language of a WAR POWERS ACT, changed the United States forever. After the passage of the Banking Relief Act, the red, white and blue flag began flying above the State flag on the same pole. This is evidence of occupation by Washington, D.C., under WAR & EMERGENCY POWERS. Before the passage of the Act, the flags flew different poles at the same height. You will sometimes see this in old movies, prior to 1933. The town square will have two flag poles, one with the State flag, the other with the U.S. flag.

Also, with the passage of the Banking Relief Act the entire legal system was overhauled. Whereas the law of the republic had been, and is, the *common law*, but since everything was now commercial, the *uniform commercial code* became the dominant law form. And so we lost our law that so many Americans died to provide for us. We're really doing great, we lost our money (gold and silver coin), and now we've lost our law. Two items closely tied to our freedom and liberty.

Now this is where it gets really interesting because the whole of government, from the Federal Level, down to the STATE OF YOUNAMEIT, down to the COUNTY OF YOUNAMEIT, down to the CITY OF YOUNAMEIT, <u>all became commercial and publically traded for profit</u>! [Publically Traded for Profit Sampling] They are all corporations. They are all WALMART with guns, living off you and your productivity! However, unlike WALMART who provides products and services you are willing to buy, Government Leadership uses a gun-barrel to force you to buy their corporate products and services!

If the reader has access to the internet, evidence of this may be found on **Dun & Bradstreet**, an online service listing *publically traded for profit entities*. If you search this service, you will find every *Office, Agency, Department, and Bureau* of government listed. Do not become confused. For example, some Sheriff's Offices are listed and some are not. But just because a particular Sheriff's Office is not listed, does not mean that it is not publically traded for profit. This is because the Sheriff's Office is part of the COUNTY OF YOUNAMEIT, and the County will be listed, therefore, that would include the Sheriff's Office. All of it to ring the Government's bankrupt cash register.

You will even find all of the Courts listed, from the Supreme Court of the United States to the Superior court of the County. Convictions are packaged and sold on a securities and exchange. And now you know why there are so many people convicted of crimes who have not harmed anyone. Every conviction of a *commercial crime* is a money-maker which rings the Government's bankrupt cash register.

This *publically traded for profit* status creates a conflict of interest. Let's take the court as an example. The court, like all Offices, Agencies, Bureaus and Departments of Government, has a *fiduciary obligation* to the people. The court's fiduciary obligation is *the administration of justice*. But now they also have an obligation to an investor. And the obligation to the investor trumps the fiduciary obligation every time and is superior to it. This creates an *irreconcilable conflict of interest* in that you cannot serve *two masters*, i.e., the *fiduciary obligation* to the people, and the *financial obligation* to an investor. It is all part of how *commercial-corporate-government* finance's itself in bankruptcy.

Every new-born child for whom the parents acquire a *birth certification* (birth-certificate) and *Social-Security-Account* has just made the child an *economic slave*, obligated to paying the debt that Leadership increases year by year. Currently (September 5, 2015), the debt is \$56,902.98 for every man, woman, and child in the United States. For a family of four, that's \$227,611.94 (mom, dad, and two children). The instant that mom and/or dad get a *Birth Certificate* and *Social Security Account* for their child, they have obligated the child to the payment of \$56,902.98, and that's today's obligation. Tomorrow it will be more. Thus, the reason for income tax. The new-born child has a *dollar value* the moment the parents acquire the Government-issued birth certificate and Social Security Account number for the child, a *dollar-value* that the United States will use to service its bankruptcy needs.

The parent who does this has publically declared themselves to be too inept and incompetent to take care of their new-born child and are petitioning the Government to take care of the child for them. Given the *dollar value* the child represents, the government will gladly take on this responsibility. Thus the parents reduce themselves to babysitter, and make Government the parent. And the Government parent will allow the babysitter to keep the child so long as the babysitter does everything the Government parent wants done!

I am aware of the claim by corporate government, that they have jurisdiction over anything that shall *issue forth* from a marriage they have *licensed*, which means *the children*. They are making this claim based in their assertion that a binding contract exists which was permitted by *license*, in this case the *marriage contract*. First, let's examine the nature of a *license*.

"License. The permission by competent authority to do an act which, without such permission, would be illegal, a trespass, a tort, or otherwise not allowable." – [Blacks Law Dictionary, sixth edition]

Very few Americans know they can marry without license. It's called a *common law marriage*, which is a marriage in the *eyes of God*, not the eyes of Government. The *common law marriage* can be as simple as a man and woman agreeing to be man and wife, entering that into the family bible, having it witnessed by a couple of friends who sign the bible, and then cohabiting as man and wife. Or it can be formalized through a marriage ceremony if the couple can find a Justice of the Peace, Pastor, Minister, or Priest who will preside over the ceremony without a *marriage license*. Remember, all of these people are obligated to corporate Government!

So, a *license* is permission to do what is otherwise illegal³. Did you know that your *marriage* was an illegal activity? NO? Remember that, it will come into play as we continue.

Did you know that your *marriage license* obligated you to a *contract*, in this case the *marriage contract*. NO? Well, remember that as well. And if YES, were you given an opportunity to view the conditions and stipulations of the contract? NO? Well guess what...

There are six elements to a valid contract. Do you know what they are? From the book *Law of Contracts* by John Calamari and Joseph Perillo, we find that a contract must contain these six crucial elements or the Contract Is Null & Void.

- 1. Offer by a person qualified to make the contract.
- 2. Acceptance by party qualified to make and accept the contract.
- 3. Bargain or agreement and full disclosure and complete understanding by both parties.
- 4. Consideration given.
- 5. Must have the element of time to make the contract lawful.
- 6. Both parties must be sui juris; that is, of lawful age, usually 21-years old.

Let's begin with item #3, *full disclosure*. Was there *full disclosure* in this *marriage contract*? Was their full disclosure in the contract your parents signed, making you an indentured servant of the corporate United States? Were you and/or your parents informed that in claiming you were a U.S. citizen, that you would be obligated to a foreign (to the republic) body of law?

Here's the deal. By tricking you or your parents into declaring you to be a "U.S. citizen", you have been converted into a *legal fiction*, in this case a *Trust and Transmitting Utility* (see <u>Shinola101</u>). All *legal fictions* are a **dead person**. An example of this would be a Corporation, or, in your case, a *Trust and Transmitting Utility*. You see, if Government Leadership were to recognize you as *a living man or woman of the land who bleeds* in their courts, then they would be legally powerless to take action against you without an *injured party*. That is another man or woman of the land who bleeds. *Bleeding* is evidence of being a **living** man or woman of the land. Dead people don't bleed! Think about it, what can you do to harm a <u>dead person</u> like corporate Government? NOTHING, that's what. It is all, and I MEAN ALL, <u>ONE BIG DECEPTION</u>!!!

And it is all accomplished by FRAUD, via DECEPTION **beginning with an invalid contract**. Invalid because it lacks *full disclosure*.

<u>Indentured Servitude</u>, what we call <u>SLAVERY</u>, is not legal in this country, especially when it is accomplished through criminal FRAUD via DECEPTION.

So, are your children subject to the will of Government Leadership? Are you subject the will of Government Leadership? In these united States of America, we are all supposed to be <u>equal in</u>

<u>the eyes of the law</u>. Therefore, Government Leadership lacks the power to compel you to a specific performance. And if we are <u>not equal in the eyes of the law</u>, then how did we become UN-EQUAL? The only way is through contracts acquired through FRAUD via DECEPTION.

This was made clear in the Clearfield decision of the United States Supreme Court (318 U.S. 363). In this decision, the Supreme Court ruled that when Government enters into <u>Commerce</u> with its citizens, <u>it loses its sovereignty status</u>, becoming no different than a private corporation, taking on the character of a mere private person when dealing in private commercial paper [Federal Reserve Notes] and securities [Checks]. Which means, when translated into English, that if Government intends to compel you to a <u>specific performance</u>, then Government, like any private corporation, or mere private person, must be the <u>holder in due course</u> of a contract or other commercial agreement, signed by you, and furthermore, be willing to enter this evidence into court in order to enforce their demands in court.

Is the Government *the holder in due course* of such a document that meets the six elements of a *lawful contract*? NO, of course not! What we are not able to predict is:

HOW CRIMINAL IS GOVERNMENT LEADERSHIP AND ADMINISTRATION GOING TO BE IN ORDER TO CONTINUE OPERATING IN BANKRUPTCY?

We already have the largest prison population per capita of any other country we wish to point at. And we constantly hear *how free we are*. Well, isn't that a laugh?

The point is that the more you learn about the *criminal nature* of Government Leadership, the better the case you can make to defend yourself and the safer you will be. It would be wise to remember that all of their current *corporation rules*, that they like to tout as **law**, are really not law, they are corporation rules. And Leadership wants to hold you subject to their corporation rules, it's what gives them power over our lives and perpetuates the deception that allows them to use our financial resources and productivity to ring their bankrupt cash register.

Reading "<u>Shinola101</u>" will be informative, but the best information I've found thus far on the *criminal deception of Government* is in "<u>My Dear Archbishop</u>", linked here.

And there you have it in a NUTSHELL. The driving force behind the whole of government policy, law and actions, is the NATIONAL DEBT. This debt has placed all the property and resources of the United States into the hands of the <u>creditor</u>. And this includes the people of the United States <u>since the people and their productivity are the only remaining renewable</u> <u>resource</u>. And the <u>United States Military</u> is not the military of the United States, it is the <u>Military of the Creditor</u>! For a long time now, the military actions we have implemented, generally base on lies (like *weapons of mass destruction*) have been for the purpose of stealing the resources of other countries for the benefit of the *creditor of the United States* (the banking elite). Iraq is a most recent example, and it looks like we are trying to start a war with Iran for the same purpose. It's the same tactic the bankers used to control England's Leadership and

force a military attack on the colonists. It was the driving force behind the colonization of Africa, India, and many other lands in a former century.

Wars have, in the past, been easy for the Banking Elite to create. Through their wealth, they either own or control the Mainstream Media (actually Mainstream Misleadia), who they have used to provide justification (read lies) for whatever

war they want to start. And then the leadership, who they also control, is given their marching orders, and the <u>CREDITORS</u> <u>MILITARY</u>, who we think of as <u>our military</u>, is mobilized and deployed. And because we have been psychologically profiled (brain washed), we have, in the past, cheered the wholesale murder of people in other countries. But, I can see that in looking at Syria and Iran, we are possibly getting smarter. The opposition to another engineered war by the American people is refreshing, good for you America.

"In a totalitarian state, it doesn't matter what people think, since the government can control people by force using a bludgeon [Government Police or Military FORCE]. But when you can't control people by force, you have to control what people think, and the standard way to do this is via propaganda (manufacture of consent, creation of necessary illusions [via the Mainstream Media]), marginalizing the general public or reducing them to apathy of some fashion." - Noam Chomsky

Do not think that government or leadership has the latitude to operate in the interest of the people, they do not have that leeway. They have to appease the creditor (the *Banking Elite*) or go down in flames, but they are NOT going to tell you that and the mainstream misleadia is not going to ferret it out and truthfully report about it either. Congressman Louis T. McFadden, President John F. Kennedy, and even President Abraham Lincoln ran afoul of the Bankers, and they went down in flames, paying the ultimate price. And in my opinion Dr. Martin Luther King belongs of this list as well. I believe that Dr. King knew what was transpiring and who was behind it, and had the potential to not only wake up and educated the American Negro, but the American White People as well. I think that Dr. King was as much a threat to the *Banking Elite* as McFadden, Kennedy, and Lincoln, and paid the price for being a threat.

A word of caution, the year is 2015. Be prepared, the economy is a zombie, it is dead. But because it appears to have some movement we think it is alive. IT IS NOT. As the rot that Leadership has allowed to be engineered by the bankers expands, the government is planning for civil unrest. That is why they have built so many <u>concentration camps</u> (do your research) and why the Department of Homeland Security has purchased 1.6-Billion bullets. That's nine-tenths of a million bullets, every-day for five-years. And the only place they have authorization to shoot those bullets is inside the borders of the United States. It is why the Police of the United States has been militarized. It doesn't take a rocket scientist to figure out that they intend to use the bullets on the people of the United States once those people figure out exactly how criminal the Leadership of the United States has been operating.

Therefore, I caution all Americans not to use violence in demonstrations, and be on the lookout for government plants who will insert themselves into a peaceful demonstration and <u>will use</u> <u>violence</u> to give police justification for using violence in return. It's a trap that, in my view, they are waiting to spring. I think leadership can hardly wait for Americans to violently revolt. REVOLT, YES! But don't do it violently, do it peacefully. The only *lawful use of force and violence* is in defense of our-selves from criminals intent on doing us harm. Unfortunately, the young people who comprise the majority of combat positions in the military may not yet be able to think and analyze. Mostly, they are trained to *just follow orders*, no thinking is allowed.

You might be able to identify criminals as those acting against the organic Constitution, Bill of Rights, and/or Declaration of Independence with the intent of destroying the republic of these united States of America and totally enslaving the people, currently through economic obligation. Perhaps they could be recognized as those legislating laws to set aside the Constitution and/or Bill of Rights, or legislating laws without the *consent of the governed*. Or maybe criminals can be recognized as those who authorize and/or participate in the murder of people who have harmed no one (Vicki Weaver, Sammy Weaver, seventy-six people at Waco, Texas of which twenty two were children, Elio Carrion, Derek Hale, Oscar Grant, etc.) Perhaps criminals can be recognized by virtue of their concealing of evidence in a crime (Federal Building bombing in Oklahoma City, Twin Towers destruction). Perhaps a criminal group can be recognized by virtue of their lies (the Gulf of Tonkin incident, weapons of mass destruction, a Boeing-767 airliner hit the Pentagon, an airliner crashed in Shanksville, Pennsylvania, office fires brought down Building 7 at the World Trade Center, the Twin Towers collapsed due to burning jet fuel, etc.). Criminals do not maintain the *republican form of Government* they are mandated to do by the Constitution.

To sum up, United States Leadership in Washington, D.C. withheld critical information from Admiral H. Kimmel regarding the *time* and *location* of the pending Pearl Harbor attack on December 7, 1941, allowing the Japanese attack to kill a couple thousand Americans. United States Leadership lied about the second *Gulf of Tonkin* attack, which led to the passage of the *Gulf of Tonkin Resolution* which, in turn, escalated the Vietnam war, resulting in the deaths of two-million Vietnamese, one-million Cambodians, another one-million Laotians and 56,000 Americans. Over four-million deaths on that lie alone.

The analysis of General Benton K. Partin made clear that the bomb damage to the Federal Building in Oklahoma City could not have been done by a bomb in the Ryder truck alone, pointing out that *cutting charges* on critical support columns had supplemented the truck bomb, and those *cutting charges* required inside access.

Then we have the "*weapons of mass destruction*" lie that United States Leadership fed the people and used as cause and reason to attack Iraq. There is now, at least, a half million people dead from that lie.

The Boston Marathon Bombing has been proven to be an inside job. The Sandy Hook shooting has been proven to be yet another hoax, i.e., an inside job. The *underwear bomber* was

manufactured or engineered by the FBI.

And last, but certainly not least are the events of September 11, 2001, billed as a **TERRORIST ATTACK** on the United States which resulted in the alleged hijacking of four airliners, two of which were allegedly used for the destruction of the *twin towers* of the *World Trade Center*, another one used to attack the Pentagon resulting in the destruction of a section of that building, and the last alleged airliner crashed outside Shanksville, Pennsylvania.

In the case of the twin towers, jet fuel could not reach the temperatures necessary to cause failure of the steel support beams that would have resulted in the catastrophic failure of the buildings structure. In addition, *World Trade Center Building-7* had not suffered any damage due to an airliner striking the building. It had a couple of small office fires, yet it collapsed in the same manner as the *Twin Towers*. But there are many other anomalies, including the fact that no independent investigation was permitted and the whole of the material from the *World Trade Center* disaster was disposed of in a manner that prevented any independent analysis.

Then there is the Pentagon. No passenger seats, no shoes, no landing gear, no jet engines... on and on the list goes. This stuff doesn't just disappear in a crash. But the really interesting thing is that on September 10, 2001, one day before this alleged **TERRORIST ATTACK**, Secretary of Defense, Donald Rumsfeld, announced that 2.3 trillion-dollars was unaccounted for at the Pentagon. And the very next day, whatever hit the Pentagon blew up the Accounting Section, ending any investigation into the missing 2.3 trillion dollars. Do we know how much 2.3 trillion amounts to? Well, if we were to spend that amount of money at one-million dollars an hour it would take 2.3 million hours to spend it. Or 95,833.3 days. Or looking at it yet another way, it would take 262.3 years to spend 2.3 trillion at one-million-dollars an hour.

Shared Traits:

- 1. A disregard for laws and social mores
- 2. A disregard for the rights of others
- 3. A failure to feel remorse or guilt
- 4. A tendency to display violent behavior

In addition to their commonalities, sociopaths and psychopaths also have their own unique behavioral characteristics, as well.

Sociopaths tend to be nervous and easily agitated. They are volatile and prone to emotional outbursts, including fits of rage. They are likely to be uneducated and live on the fringes of society, unable to hold down a steady job or stay in one place for very long. It is difficult but not impossible for sociopaths to form attachments with others. Many sociopaths are able to form an attachment to a particular individual or group, although they have no regard for society in general or its rules. In the eyes of others, sociopaths will appear to be very disturbed. Any crimes committed by a sociopath, including murder, will tend to be haphazard, disorganized and spontaneous rather than planned.

Psychopaths, on the other hand, are unable to form emotional attachments or feel real empathy with others, although they often have disarming or even charming personalities. Psychopaths are very manipulative and can easily gain people's trust. They learn to mimic emotions, despite their inability to actually feel them, and will appear normal to unsuspecting people. Psychopaths are often well educated and hold steady jobs. Some are so good at manipulation and mimicry that they have families and other long-term relationships without those around them ever suspecting their true nature.

When committing crimes, psychopaths carefully plan out every detail in advance and often have contingency plans in place. Unlike their sociopathic counterparts, psychopathic criminals are cool, calm, and meticulous. Their crimes, whether violent or non-violent, will be highly organized and generally offer few clues for authorities to pursue. Intelligent psychopaths make excellent white-collar criminals and "con artists" due to their calm and charismatic natures.

The cause of psychopathy is different than the cause of sociopathy.⁴ It is believed that psychopathy is the result of "nature" (genetics) while sociopathy is the result of "nurture" (environment). Psychopathy is related to a physiological defect that results in the underdevelopment of the part of the brain responsible for impulse control and emotions.

Sociopathy, on the other hand, is more likely the product of childhood trauma and physical/emotional abuse. Because sociopathy appears to be learned rather than innate, sociopaths are capable of empathy in certain limited circumstances but not in others, and with a few individuals but not others.

Psychopathy is the most dangerous of all antisocial personality disorders because of the way psychopaths dissociate emotionally from their actions, <u>regardless of how terrible those actions</u> <u>may be</u>. Many prolific and notorious serial killers, including the late Ted Bundy and John Wayne Gacy, and Dennis Rader ("Bind, Torture, Kill" or BTK) are unremorseful psychopaths. Psychopathic killers view their innocent victims as inhuman objects to be tormented and violated for their amusement.

Returning to World War II and driving the point of psychopathic / sociopathic behavior home:

The Japanese had been privately and quietly *suing for peace* for some time when the meeting below was conducted.

"[Secretary of State Edward] Stettinius called the meeting to order to discuss an urgent matter; the Japanese were already privately suing for peace, which presented a grave crisis. <u>*The atomic bomb*</u> would not be ready for several more months. 'We have already lost Germany,' Stettinius said. 'If Japan bows out, we will not have a live population on which to test the bomb.' – The Secret History of the Atomic Bomb; Mullins, June 1998

Yes, I know, this meeting took place in the mid 1940's when a whole different set of individuals comprised the Leadership of the United States, but they were the same brand of individual that has occupied positions of Leadership a long time before and still occupy positions of Leadership today. And one might notice that Stettinius was disappointed that Germany had already surrendered, leading one to conclude that he would have been happy to have dropped the Atomic Bomb on Germany. No doubt the Leadership of the United States would like to distance their selves from the crimes they have committed and continue to commit, but it would not be wise of the people of the United States to allow them to do so. Every Office, Agency, Bureau and Department of Government, along with their *military* and *code enforcers* are a reflection of, and acting on behalf of the psychopathic/sociopathic criminals at the top.

And this, in my opinion, perhaps yours as well, sums up United States Leadership for a long time, up to and including the present.
