GUN VIOLENCE PREVENTION Working Group - Public Hearing January 28, 2013

Henson Ong speaking

My name is Henson Ong. Forgive me, English is not my first language.

I am a *legal immigrant* and I am an AMERICAN by CHOICE. Thank you for giving me this opportunity to express my opinion and to give my testimony in opposition to the majority of the proposed bills which do nothing to deter future crimes. Gun Control does not work! Your own history is replete with *High School rifle teams, Boy Scout Marksmanship Merit Badges*, [in the sixty's] you could: 1) buy rifles at the hardware stores, 2) you could mail order [guns] and have them delivered to your home, your country was awash with readily available firearms and ammunition. And yet, in your past you did not have *mass school shootings*. Other people have already expressed the question: "WHAT CHANGED???"

It was not that the availability of guns suddenly exploded or suddenly increased, it actually was decreased. What changed was **societal decay**. [Which we may recognize as intentional mismanagement by Leadership.] If <u>Gun</u> <u>Control</u> actually did work, Washington, D.C. and Chicago would be the safest cities in your nation, but **ARE NOT!** They have the toughest gun laws and the highest crime and murder rates.

Now, some people have called the AR-15 a weapon of *mass killing*. Well, it turns out that there are a few Government Agencies which disagree with that characterization. The *Department of Homeland Security* has stated that a rifle chambered in 5.56 NATO [which is the AR-15] with a 30-round magazine, is suitable for personal defensive use. Documentation on that is *HSCEMS-1212-00011*, solicitation for Immigration and Customs Enforcement Agency.

Now, who needs an AR-15 with 30-round magazines [clips]? That question has also been brought up. And I would like to put forward that had the Koreans in the Los Angeles-Riots not had AR-15's and AK-47's with 30-round magazines, and Rugar 30's, their businesses would have been burned to the ground like all of the other businesses in their neighborhoods. Their's stood, because they *stood their ground*. I would also put forward to conjecture that the ten-thousand (10,000) students at Tiananmen Square [freedom rally in China] NOT BEEN UN-ARMED, things may not have resulted in so many of them disappearing.

In your own laws – United States vs. Miller, 309 U.S. 174 (1939) – it was made clear that the type of firearms protected by the Second Amendment were those specifically useful and common for military use in defense of the State. I would like to note that <u>the State</u> is **not** the Government, <u>the State</u> is the people. In *Lewis vs. United States (1980)*, the Second Amendment guarantees no right to keep and bear arms that does not have some reasonable relationship to the preservation and efficiency of a well regulated militia. It has NOTHING to do with hunting!

The militia as per the debates in the convention shows plainly enough that it is composed of all males physically capable of acting in concert for common defense. And further, that ordinarily when called for service these men were expected to appear bearing arms supplied by themselves and of the kind in common use at the time. The AR-15 **is** the most common and popular rifle in America at this time.

I will wrap up. I would like to wrap up with a statement from Judge Andrew Kozinski in Silveira v. Lockyer (2003).

"My excellent colleagues have forgotten these bitter lessons of history. The prospect of tyranny may not grab the headlines the way vivid stories of gun crime usually do. But few saw the Third Reich coming until it was too late. The Second Amendment is a doomsday provision; one designed only for those exceptionally rare circumstances when all other rights have failed. **A free people can only afford to make this mistake once**."

We should not forget the lies we Americans have been told over the years in order to manipulate our perceptions and beliefs. We now know that the Central Bankers (Banking Elite) have controlled Leadership for a long time, by and through the national debt owed to these bankers. Leadership, whether, or not, believing in the goals of the Banking Elite have been, more or less, obligated to implement those goals, which often involve the brainwashing of the American people.

The value of conflict, the TRUE VALUE, is in the DEBT that the conflict produces. Control the DEBT and YOU CONTROL EVERYTHING. This is essence of the <u>banking industry</u>. To make us all, whether we be nations or individuals, slaves to debt.

Briefly examining some specific events targeting the manipulation of the minds of the American people, in the late 1930's President Franklin Roosevelt implemented an 8-point plan that would likely result in forcing Japan to attack the United States. By the time Japan finally decided to attack the United States, Code breakers in Washington, D.C. had broken both the <u>Diplomatic</u> and <u>Military</u> communications codes, and had notified President Roosevelt of the pending attack on Pearl Harbor by Japan, the date of the coming attack as well as the time scheduled for the attack. Roosevelt, either under orders from the Banking Elite, or of his own accord, did not notify the Pacific Military Commanders of the coming attack so that they could prepare. The result was the loss of the majority of the Pacific Fleet of ships, and over two-thousand American lives. Even if this was not ordered by the Banking Elite, it was certainly condoned (supported) by them. The U.S. entered World War II and the Banking Elite, along with the <u>Military / Industrial Complex</u> began making money hand over fist. "In the councils of government, we must guard against the acquisition of unwarranted influence, whether sought or unsought, by the militaryindustrial complex. The potential for the disastrous rise of misplaced power exists and will persist. We must never let the weight of this combination endanger our liberties or democratic processes. We should take nothing for granted. <u>Only an alert and knowledgeable citizenry</u> can compel the proper meshing of the huge industrial and military machinery of defense <u>with our peaceful methods and goals</u>, so that security and liberty may prosper together." – President Dwight D. Eisenhower, exit speech.

In a separate incident, United States leadership concocted the <u>Gulf of Tonkin</u> lie. In short, there were two <u>Gulf of Tonkin</u> incidents. In the first, North Vietnam was under attack by the South Vietnamese Navy and the Laotian Air Force. Thus, there attack on the USS Maddox, which was engaged in aggressive intelligence gathering in North Vietnamese waters, was justified. The second incident, which was used to gain passage of the <u>Gulf of Tonkin</u> <u>Resolution</u>, which escalated the Vietnam War, never occurred. IT WAS A LIE. Out of that lie, four million Asians died, two-million Vietnamese, one-million Cambodians, and one-million Laotians, and fifty-six thousand Americans. And U.S. Leadership did not care who died, nor how many, and that has been the case for very long time.

A more recent LIE was <u>WEAPONS OF MASS DESTRUCTION</u>, which George W. Bush touted as cause and reason to attack Iraq and bomb them back into the *stone-age*. We murdered over a million Iraqi's and installed a puppet government in order to steal their oil resources!

Then there was the LIE that the leader of Syria had *gassed* his own people and that conflict is still going on as I write (October 8, 2016). U.S. Leadership wants a pipeline through Syria, and since Assad, the Syrian leader, was opposed to it, the U.S. decided that a leadership change was necessary in Syria. And they have been concocting one LIE after another to brainwash the American people into supporting this war. It appears that the U.S. is currently losing this war. If they do, as I suspect they will, then the value of the [petro] dollar collapses, and along with it, our economy collapses.

And our failing economy is why our Leadership is now trying to start a war with Russia, China, North Korea and Iran. U.S. Leadership needs World War 3 to avoid having responsibility for the coming economic collapse assigned to them and their Banker Controllers. They are now implementing plans to bring down our economy in a controlled manner, **BUT**, if the margin between Hillary supporters is too far behind Trump supporters, then it will not be possible for them to **scam the election** and get Hillary installed as President. If the margins are close, then, since they control the computer-programs in the voting machines, they can use the voting machine program to manipulate the vote count in real time, and no one will be the wiser. Hillary will be elected, and the Bankers plan continues.

But, if it appears that Trump may be elected by a wide margin, watch out for an unbelievable <u>False Flag Life Ending Event</u>. One so monumental that it may be difficult to believe that Leadership is behind it. But Leadership has pushed the criminal-limits so far now, that a monumental loss of American lives is of no consequence or concern to Leadership, so long as they are not blamed.

It is difficult to predict what **psychopath Leadership** is going to do because they do not believe they have any limits on their behavior. And, to put it bluntly, they have been operating criminally for so long without any consequences, I suspect they believe themselves to be immune from accountability. And this makes life monumentally dangerous for all Americans, whether those Americans are aware or not.

"Most people prefer to believe that their leaders are just and fair, even in the face of evidence to the contrary, because once a citizen acknowledges that the government under which he lives is lying and corrupt, the citizen has to choose what he or she will do about it. To take action in the face of corrupt government entails risks of harm to life and loved ones. To choose to do nothing is to surrender one's self-image of standing for principles. Most people do not have the courage to face that choice. Hence, <u>most</u> **propaganda** is not designed to fool the critical thinker but only to give moral cowards an excuse not to think at all." - Michael Rivero

But I will take this one step further, <u>to do nothing will still entail risk of harm</u> <u>and death to loved ones</u>. We see it all the time, simply take a look at the number of Americans murdered by police every year. Only very rarely are murderous policemen held criminally accountable. **Many Americans died to provide you with the right to bear arms**. Should you give up that right, not privilege, **RIGHT**? RIGHTS are nearly impossible to get back once you give them up. And those who came before you and died to provide you with those RIGHTS will certainly feel stabbed in the back.

"A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed." – Second Amendment, Constitution **for** the United States

It is clear that the framers of the Constitution assigned the responsibility of protecting the country to its male population between the ages of 17 to 45. The courts have agreed that the Police have no obligation to protect anyone other than themselves. Therefore, the Police have no duty to protect your family or property, that's your job. So, are we Americans going to flush our responsibility and leave ourselves unable to protect our family?

Those, who either *don't care* or *can't think*, are a danger to all of us who do care and who can think!

BRAIN WASHING THE PEOPLE INTO WAR

"Naturally the common people don't want war: Neither in Russia, nor in England, nor for that matter in Germany. That is understood. But, after all, it is the LEADERS of the country who determine the policy and it is always a simple matter to drag the people along, whether it is a democracy, or a fascist dictatorship, or a parliament, or a communist dictatorship. Voice or no voice, the people can always be brought to the bidding of the leaders. That is easy. All you have to do is TELL THEM THEY ARE BEING ATTACKED, and denounce the peacemakers for lack of patriotism and exposing the country to danger. It works the same in any country." -- Hermann Goering, Adolf Hitler's second in command, speaking during the Nuremberg Trials of Nazi war criminals at the end of World War II.

And we should remember that the NAZI party was responsible for the burning of the Reichstag Building, the equivalent of our Congress as I understand it, and then blamed the fire on some other group or party. A **FALSE FLAG EVENT** is used to implement laws that gave Leadership more control over the population, and there has certainly been a lot of them in the United States in recent times, going back to the World Trade Center – and event for which no one has accepted responsibility. "Terrorism" only works if you make the people aware of their power and that no one is safe from the terrorists. "Terrorism" is generally only effective when implemented by the Government of the target people! Of course, Leadership will tell the people that the taking for their freedom and liberty is necessary to protect them. Your greatest loss of freedom will take place in the name of <u>safety</u>.

So, how stupid do Americans want to be? I'm going to have to quit asking this question, too many Americans are accepting it as a challenge.

1. GLIB and SUPERFICIAL CHARM — The tendency to be smooth, engaging, charming, silky, slick, and verbally facile. Psychopathic charm is not in the least shy, self-conscious, or afraid to say anything. A psychopath never gets tongue-tied. They have freed themselves from the social conventions about taking turns in talking, for example.

2. GRANDIOSE SELF-WORTH — A grossly inflated view of one's abilities and self-worth, self-assured, opinionated, cocky, a braggart. Psychopaths are arrogant people who believe they are superior human beings.

3. NEED FOR STIMULATION or PRONENESS TO BOREDOM — An excessive need for novel, thrilling, and exciting stimulation; taking chances and doing things that are risky. Psychopaths often have low self-discipline in carrying tasks through to completion because they get bored easily. They fail to work at the same job for any length of time, for example, or to finish tasks that they consider dull or routine.

4. PATHOLOGICAL LYING — Can be moderate or high; in moderate form, they will be shrewd, crafty, cunning, sly, and clever; in extreme form, they will be deceptive, deceitful, underhanded, unscrupulous, manipulative, and dishonest.

5. CONNING AND MANIPULATIVENESS — The use of deceit and deception to cheat, con, or defraud others for personal gain; distinguished from Item #4 in the degree to which exploitation and callous ruthlessness is present, as reflected in a lack of concern for the feelings, suffering and life of one's victims.

6. LACK OF REMORSE OR GUILT — A lack of feelings or concern for the losses, pain, suffering and life of victims; a tendency to be unconcerned, dispassionate, cold-hearted, and non-empathic. This item is usually demonstrated by a disdain for one's victims.

7. SHALLOW AFFECT — Emotional poverty or a limited range or depth of feelings; interpersonal coldness in spite of signs of open gregariousness.

8. CALLOUSNESS and LACK OF EMPATHY — A lack of feelings toward people in general; cold, contemptuous, inconsiderate, and tactless.

9. PARASITIC LIFESTYLE — An intentional, manipulative, selfish, and exploitative financial dependence on others as reflected in a lack of motivation, low self-discipline, and inability to begin or complete responsibilities.

10. POOR BEHAVIORAL CONTROLS — Expressions of irritability, annoyance, impatience, threats, aggression, and verbal abuse; inadequate control of anger and temper; acting hastily.

11. PROMISCUOUS SEXUAL BEHAVIOR — A variety of brief, superficial relations, numerous affairs, and an indiscriminate selection of sexual partners; the maintenance of several relationships at the same time; a history of attempts to sexually coerce others into sexual activity or taking great pride at discussing sexual exploits or conquests.

12. EARLY BEHAVIOR PROBLEMS — A variety of behaviors prior to age 13, including lying, theft, cheating, vandalism, bullying, sexual activity, fire-setting, glue-sniffing, alcohol use, and running away from home.

13. LACK OF REALISTIC, LONG-TERM GOALS — An inability or persistent failure to develop and execute long-term plans and goals; a nomadic existence, aimless, lacking direction in life.

14. IMPULSIVITY — The occurrence of behaviors that are unpremeditated and lack reflection or planning; inability to resist temptation, frustrations, and urges; a lack of deliberation without considering the consequences; foolhardy, rash, unpredictable, erratic, and reckless.

15. IRRESPONSIBILITY — Repeated failure to fulfill or honor obligations, promises and commitments; such as not paying bills, defaulting on loans, performing sloppy work, being absent or late to work, failing to honor contractual agreements.

16. FAILURE TO ACCEPT RESPONSIBILITY FOR OWN ACTIONS — A failure to accept responsibility for one's actions reflected in low conscientiousness, an absence of dutifulness, antagonistic manipulation, denial of responsibility, **and**

an effort to manipulate others through this denial.

17. MANY SHORT-TERM MARITAL RELATIONSHIPS — A lack of commitment to a long-term relationship reflected in inconsistent, undependable, and unreliable commitments in life, including marital.

18. JUVENILE DELINQUENCY — Behavior problems between the ages of 13-18; mostly behaviors that are crimes or clearly involve aspects of antagonism, exploitation, aggression, manipulation, or a callous, ruthless tough-mindedness.

19. REVOCATION OF CONDITION RELEASE — A revocation of probation or other conditional releases due to technical violations, such as carelessness, low deliberation, or failing to appear.

20. CRIMINAL VERSATILITY — A diversity of types of criminal offenses, regardless if the person has been arrested or convicted for them; **taking great pride at getting away with crimes**.

The word psychopath can be replaced with the word sociopath throughout this page. The meaning is very similar, if not the same.
