On the 19<sup>th</sup> through the 21<sup>st</sup> of this month (August 2009) an *International Swine Flu Conference* was evidently held at Hyatt Regency Washington on Capitol Hill, 400 New Jersey Avenue, NW, Washington, D.C., USA 20001. The flyer (or notification of this event) has this to say in its first paragraph:

"Top leaders and key decision-makers of major companies representing a broad range of industries will meet with distinguished scientists, public health officials, law enforcers, first responders, and other experts to discuss pandemic prevention, preparedness, response and recovery at the 1st International Swine Flu Summit." - http://www.cesa.net/DOCS/08192009.PDF (Remember to type upper and lower case exactly as

The first news worthy item in this event is that the main stream *misleadia* is evidently ignoring this international conference. Rule #1: if the main stream *misleadia* ignores an international

event, it is most likely detrimental to the American people.

The first topic covered is "Mass Fatality Management Planning." Under this heading there are a few sub-topics that stand out. The first is *Conduct Morgue Operations*. As far as I know, the Swine Flu, to date, has not shown itself to be any more deadly than many other flu's currently in existence. Is there something planned or in the works we don't know about? Swine Flu has certainly not been a major news item for a while.

Also under this heading is *Activate Fatality Management Operations*. Since this is *international*, it would seem that there is expected a great deal of death. Certainly sounds like something the main stream *misleadia* should be reporting.

Under the next topic of *Psychology Issues* we have the following sub topics: 1) Public's distress of exposure and safety; 2) Breakdown of public services, utilities; 3) Medical supplies shortage; 4) Unwillingness to follow government orders. Given that the government has so openly lied to the American public (Gulf of Tonken for instance), given that government acts to take the freedom of the American public at every opportunity and excuse, given that our elected officials do not fulfill their *campaign promises* to the American public, given that government murdered hundreds of thousands of Iraqi's under the lie of *weapons of mass destruction*, I can't imagine why some awake American's might not want to follow *government orders*. As far as I know, the government can not <u>order</u> the American people around unless they are planning the implementation of <u>martial law</u>, in which case the American people are <u>ordered</u> & <u>controlled</u> through violence.

Under the topic of *Continuity of Operations (COOP) and Continuity of Government Planning* we have sub-topics of: 1) When 50% or more of employees are out sick or taking care of their sick

ones; 2) When H1N1 flu pandemic unfold in two or three successive waves in a calendar year; 3) Disruptions to public, private and critical infrastructure undermining your essential functions. I'm getting the feeling there is a lot known that we (the people) are not being told. Maybe we should stop watching so much television and pay a little attention to what is unfolding around us.

Under the topic *Emergency Management Services* we have sub-topics of: 1) Prioritize antivirals & personal protective equipment for essential workforce; 2) Overcome reduced response capacity caused by mechanical failure & a possible 30-40 percent drop in staff, to maintain continuous operations.

A 30-40 percent drop in staff sounds ominous, certainly news worthy.

Under the topic *First Responders: Fire Department* we have sub-topics of: 1) Protect fire department first responders from falling ill & from being hurt in civil disturbances; 2) Continue to respond to routine fire outbreaks while responding to pandemic-related calls; 3) Effectively transition into <u>*All-Hazards Incident Management Responders*</u>; 4) Effectively undertake mass vaccinations; 5) Enforce quarantines.

For *Fire Department* personnel to <u>undertake mass vaccinations</u> would, to me, mean that we are going to be <u>force vaccinated</u>, otherwise the American people would go to a clinic and be voluntarily vaccinated by medical professionals. And for the *Fire Department* to <u>enforce</u> <u>quarantines</u> suggests that those diagnosed, or suspected, of being ill will be placed in some sort of containment facility with others who are sick and **forced** to remain quarantined.

Keeping the column short here is a short list of some other sub-topics you may find disturbing or ominous. 1) Protect police forces from falling ill & from being hurt in civil disturbances; 2) Control & diffuse social unrest & public disorder; 3) Isolate prisons & other facilities; 4) Anticipate interruptions in food, fuel and essentials supply chains & establish stockpiles; 6) Plan for 30-40 percent drop in labor force.

Item 1 in the previous paragraph suggests that because we *catch the flu*, we are going to become disruptive. I do not see that as a reason for the American people to become disruptive unless they come to the conclusion that the government is responsible. Item 2 follows suit in predicting that because we catch the flu, we are going to become disorderly and engage in social unrest activities. Personally, I don't see illness as a cause or reason for public unrest or disorderly conduct. Item 3 suggest that prisons and *other facilities* be isolated. What *other facilities*? And I thought that prisons were already "isolated." This leads me to the opinion that I don't know what *they* mean when they're using the term "isolated."

Question: Is this to be the catalyst to convince the American public that they need government health care and *<u>national identification</u>* or bio-chip implant?

The problem in all of this is that I, and others like me, can sometimes find such information as related above, but our warnings may be a bust. In other words we may be set up to cry wolf

when none exists. Then when the real wolf appears and we once again make our call, we will be ignored. Therefore, I am not predicting anything here, I am simply relating an event, in this case a conference, which may or may not be something you should consider. In the end, your safety, your health, and your freedom begin with you.
