I'm going to ask a question and I would like you to answer the question as soon as you read it. No more than 5 seconds. The idea is for you to get a feel for your own perception. Actually it takes 114 years to spend a billion

dollars at one thousand dollars per hour. Since a billion is a thousand millions, then at \$1000 per hour, it takes a million hours. Remembering that there are 24 hours in a day, and that a year is 365.25 days (don't forget leap year), then there are 8766 hours in a year. Divide one million by this number:

1,000,000 / 8766 = 114.077

Or, approximately 114 years. And now you have a feel for a billion dollars.
